The Commissioners will meet for a briefing of the agenda items at **6:45 PM**. This will be a public meeting; however, no testimony will be heard and no action will be taken on the agenda items.

The agenda will be as follows:

2. Consent Agenda

The Consent Agenda includes items that are administrative actions where no additional discussion is needed. If there is any opposition or comment, the item will be taken off the consent agenda and put on the regular administrative session meeting agenda for discussion. - b. Cory Andersen seeking a recommendation for a proposed amendment to the Official Zone Map from the R2 Single/Two-Family Residential Zone and the CC-Community Commercial Zone to the RMF-2 Multi-Family Residential Zone for approximately 12 acres of property in the area of 600 South Main.
